When compared to other states in Australia we can see that the children in South Australia are missing out on vital support to be successful learners. We need to let the Minister know and understand what is happening

Invite to contribute to newsletters	Recently the Department for Education had a review into the Early Intervention Hearing Services provided by the department for children 0-5 years of age. This included the Early Intervention Service for Deaf and Hard of Hearing babies and young children based at Special Education Resource Unit (SERU) and the Special

The review brief was to gather information about current services provided by both the Department for Education as well as understand the early intervention services available from other providers. The review identified that some services available through NDIS
2019 Membership form	registered providers were duplicated by the EISDHH service within the department. It also highlighted that not all children with a hearing loss can access NDIS, however the research provided stated it is clear that there are long term

benefits for children with any hearing loss who access early intervention services. One of the key findings was the need for further work to determine what and if

The biggest key finding was that the current early intervention landscape is presently very complex. One of the recommendations was to continue services through 2019 -2020 which is not in alignment with when country based Special

any adjustments to the current service model be required.

Educators (Hearing) position tenure finishes.

Yes, I agree these are very complex times, but we do not need them to become more complex and we need all parents to feel they are supported with the choices they make. But parents and families of new born and newly diagnosed children do not know what they don't know about the impact of deafness on their child's learning and neither do a majority of planners organising NDIS plans. We all know first-hand stories of what parents have been told or not given the correct information by their planners, and how this can influence the decisions they make about the communication and educational needs of their children. Before this becomes a full-on rant about my own personal concerns about NDIS and early intervention, I just want you all to think about the seriousness and knock on effects of this review and what the outcomes could possibly become after 2020.

On a lighter note, World Teachers Day celebrations were once again hosted by CEASA, who are now called Educators SA (CEASA). This year the awards took place at the Adelaide Convention Centre and I am pleased to say AATD (SA) was once again well represented. Congratulations go to Julie Daly who won the AATD (SA) Award for excellence for her contribution to working with DHH babies, families and students. Julie has worked as a ToD in SA for many years and held a variety of positions. She was one of the people at the forefront when Klemzig School became an Auslan Bilingual School. Julie also worked at a visiting ToD with the Hearing Services team before they were dismantled and has worked in the Early Intervention Service DHH for a number of years.

This year the AATD (SA) association was nominated for an award for associations who showed leadership and innovative practices for the way they managed and ran the ANZCED 2018 conference. This was a huge achievement for the ANZCED committee who coordinated the whole event from start to finish without getting outside help (Conference organisors and website managers). I would like to thank everyone involved once again for a job well done. Thank you also goes to Mandy Conner who did a great job coordinating the ToD Awards.

Again, I would like to mention all the people working towards their Teacher of the Deaf Master courses. Keep going, another semester is almost finished which means you will have learned more to guide you in your work and make you think more deeply about the children you are working with.

There are a range of categories of membership to the National Association of Australian Teachers of the Deaf. Please select the category you wish to be considered for and contact a member of your state branch to access a membership form.

Full membership

This category is open to holders of awards in the education of Deaf and Hearing Impaired students approved by the Committee. You must provide a university transcript documenting your studies in an approved university program.

Full membership- CPE Current Membership

This category is open to full members who meet an additional mandatory CPE requirement of a minimum of 15 hours approved CPE every two years. This CPE may include professional reading, participation in online lectures, courses and workshops, and engagement in accredited CPE events. These activities must be directly related to the education of children and students who are deaf.

Associate membership

This category is open to any personnel working with Deaf and Hearing Impaired children and students. This may include speech pathologists, occupational therapists and audiologists.

Student membership

This category is open to students undertaking study in the field of education of Deaf and Hearing Impaired children and students.

Life membership may be offered to any member who, in the opinion of the Committee has made an outstanding contribution to the education of Deaf and Hearing Impaired students.
